Dosage Rate:

PRI-ECO is dosed at 1:20,000 (one liter per 20 mt). It is recommended that any ships using **PRI-ECO** during all bunkerings, use a dose rate of one liter per 10 metric tons, for the first two months (approximately two bunkerings) of application. Then revert back to the 1:20 dose rate henceforth.

Dosage Method:

Power Research Inc. suggests **PRI-ECO** is highly miscible with VLSFO/HFO and may be added directly to tanks prior bunkering. Agitation from fuel flow into the tank typically provides a sufficient mixture.

Quality control:

PRI-ECO is manufactured in accordance with strict, chemical manufacturing standards. Each blend is numbered, and a retain sample is FTIR tested against a laboratory standard to ensure optimal conformance.

Miscibility:

PRI-ECO is a highly complex blend of organic chemistries that, once blended with, will not stratify or separate, even with fuel purification. In fact, purification systems remain cleaner and more efficient when processing **PRI-ECO** treated fuels.
